**DIRECTOR:** Each year, there is **a single vacancy** on the SDRA Board for the position of **Director**. *Eligibility to serve, per our by-laws, requires that you are a member in good standing and have been an SDRA member for at least one year.*

- 3-year term
- Expected to attend all or most Board Meetings (*can be done electronically when necessary*)
- Hopefully would be able to help out from time to time on activities.

**OFFICERS:** Serve 2-year terms, with a maximum of 2 sequential terms in the position held. *Eligibility to serve, per our by-laws, requires that you are a member in good standing and have been an SDRA member for at least 3 years.* **All officer positions are open**; this unusual occurrence came about because the change in by-laws to 2-year terms for officers meant filling all 4 slots at the same time.
